The Information Form provides Santa and Mrs. Claus with information to chat with the child. Remember that Santa knows *everything*, so please complete it thoroughly.

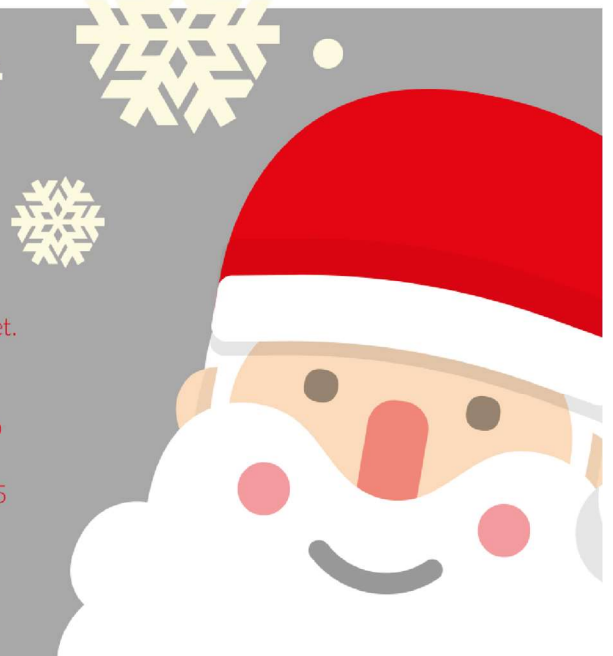
